



# Pregled nižih i viših stopa poreza na dohodak

Općine i gradovi sami propisuju nižu i višu stopu poreza na dohodak za godišnje poreze koje se koriste kod obračuna dohotka od nesamostalnog rada, samostalne djelatnosti i drugog dohotka (koji nije konačan) ovisno o broju stanovnika, u granicama propisanim Zakonom o porezu na dohodak (Nar. nov., br. 115/16, 106/18, 121/19, 32/20, 138/20, 151/22 i 114/23). Općine i gradovi koji nisu donijele odluku o stopama poreza na dohodak primjenjuju nižu stopu od 20% i višu stopu od 30%. U članku se daje tabelarni prikaz nižih i viših stopa poreza na dohodak po općinama i gradovima u RH.

## 1. Određivanje stopa poreza na dohodak

Sukladno čl. 19. Zakona o porezu na dohodak, godišnji porez na dohodak plaća se po nižoj stopi na poreznu osnovicu do visine 50.400,00 eura te po višoj stopi na dio porezne osnovice koji prelazi iznos od 50.400,00 eura.

Prema čl. 19.a Zakona o porezu na dohodak, visine poreznih stopa određuju predstavnička tijela jedinica lokalne samouprave svojom odlukom.

Predstavničko tijelo jedinica lokalne samouprave može svojom odlukom propisati visine poreznih stopa u granicama propisanim Zakonom o porezu na dohodak, i to:

- 1) općina – nižu stopu u granicama od 15 % do 22 % te višu stopu u granicama od 25 % do 33 %
- 2) grad s manje od 30.000 stanovnika nižu stopu u granicama od 15 % do 22,40 % te višu stopu u granicama od 25 % do 33,60 %
- 3) grad s više od 30.000 stanovnika nižu stopu u granicama od 15 % do 23 % te višu stopu u granicama od 25 % do 34,50 %
- 4) Grad Zagreb nižu stopu u granicama od 15 % do 23,60 % te višu stopu u granicama od 25 % do 35,40 %.

Odluka predstavničkog tijela jedinice lokalne samouprave objavljuje se u „Narodnim novinama“, donosi se najkasnije do kraja studenoga tekuće godine, sa stupanjem na snagu 1. siječnja iduće godine i primjenjuje se do donošenja nove odluke. Jedinice lokalne samouprave dužne su odluku svog predstavničkog tijela dostaviti Ministarstvu financija, Poreznoj upravi u roku od 8 dana od dana njezina donošenja radi objave na mrežnim stranicama Porezne uprave.

Nižu stopu od 20% i višu stopu od 30% primjenjuju jedinice lokalne samouprave, čija predstavnička tijela nisu donijela u roku odluku kojom se propisuje visina poreznih stopa.
